CAPABILITIES

- **Save/Edit/Return:** Save a specific frame or snapshot and redact sensitive elements to retain privacy, security and safety.
- **Run In Background:** Run multiple facial recognition, object tracking, or export rendering tasks in the background.
- **Any Object Tracking:** Auto-track identifying features, including tattoos, license plates, and street signs.
- **Redaction Options and Intensities:** Pixelation, mosaic, fill, blur, and outline, in box or oval shapes, with thirty-six user selectable colors/shades.
- **Edit Speeds:** Quick selectable speeds of 0.1x, 0.2x, 0.5x, 0.8x, 1x, 1.2x, 1.5x, 2x, and 4x and frame-by-frame viewing/editing.
- **Audio Redaction:** Search for specific words in an audio file (multiple language support) and redact with beep, silent or scrambled audio.
- **Export Range Selection:** Redact only the portion desired, or the entire original video as necessary.
- **3rd Party Video Support:** Supports most industry standard video formats.
- **Safe Fleet Video Support:** Supports most Safe Fleet In-Car Video System and FOCUS body camera videos natively.
